**Missing Child Case Profiled on NetPosse.com to  
Air on America's Most Wanted  
Slated to Air Saturday, August 4, 2007, at 9 pm EST**

**Horse could be Link in Federal Fugitive  
and Missing Child Case**



Shelby, North Carolina – August 3, 2007 – The missing child case of **Mary Nunes** from New Hampshire was first brought to international attention after being profiled on **Stolen Horse International's** Web site, [www.NetPosse.com](http://www.NetPosse.com), Nov. 10, 2006. This past March, **America's Most Wanted** joined forces with the **U.S. Marshals Service** in an effort to locate this missing child allegedly abducted by her stepfather, **Scott Kelley**, a former special education teacher from Woodsville, N.H., and her mother **Genevieve Kelley**, a prominent New Hampshire physician – both federal fugitives wanted by U.S. Marshals Service. Mary was abducted on October 22, 2004, from her home in Whitefield, N.H.

**On Saturday, August 4, 2007, America's Most Wanted (9 pm EST) is tentatively scheduled to air a brief segment featuring Mary and her alleged abductors.** AMW, authorities and Stolen Horse International (SHI) are requesting the help of the public and the equine community in solving this case. The horse that could be the link is believed to be a bay Appendix Quarter Horse gelding possibly named Nicky.

SHI's involvement in this case began in July 2006, after Debi Metcalfe, president, received a phone call from a Deputy U.S. Marshal. Since that time, Debi and Angela Kirby, NetPosse's volunteer executive coordinator, have developed a close working relationship with investigators in a joint effort to leave no stone unturned as the search for Mary and her abductors continues.

The equine community knows **Debi Metcalfe** as the horse world's equivalent to **John Walsh**, and Stolen Horse International is the organization that locates stolen and missing horses, tack and trailers, just as America's Most Wanted helps law enforcement search for missing children and wanted fugitives.

With the combined forces of the U.S. Marshals Service, the National Center for Missing and Exploited Children, America's Most Wanted and Stolen Horse International, it is only a matter of time before these fugitives will be identified and located with your help so that Mary can be reunited with her father. Given Genevieve's ability to speak fluent Spanish, authorities believe the fugitives may have fled to a Spanish speaking country outside the U.S. or to one of its territories. However, she may have assumed a new identity and be stateside. Keep in mind, though, these fugitives could be anywhere. It is also possible that Mary Elizabeth Nunes does not realize that she has been abducted. SHI was formed because of Debi's personal experience after her family's horse, Idaho, was stolen in 1997 and recovered fifty-one weeks later, through their personal efforts. Over the last ten years, Debi has become the renowned authority on horse theft as she has worked with victims, law enforcement agencies and the court systems to recover horses, and spoken at myriad events in an effort to educate the public.
